There is no **Copayment** or **Deductible** applied to this coverage.

Benefits

We will pay the **Actual Costs** incurred for **Wellness Services** Your **Pet** receives from a licensed **Vet** during the **Policy Period**, up to the applicable Wellness Maximum Limit shown in the Wellness Benefit Schedule. Benefits will not exceed the applicable Maximum Benefits shown below.
